

SAPIC Patricia Shaw Memorial Grant Application Instructions

The State Association for the Preservation of Iowa Cemeteries (SAPIC) makes available each year two grants: one for cemetery workshops and one for general cemetery work.

- Applicants must be SAPIC members (dues individually, \$25; household, \$35; business or organization, \$40. Membership may accompany the grant application if a non-member).
- Grants are generally issued up to \$500.
- Grant applications must be received by **March 1**, with the money to be granted that spring.

Workshop Grants

The purpose of workshop grants is, specifically, to promote cemetery care and gravestone repair and does NOT include related physical improvements such as brush removal, fencing, signs, chemicals, etc.

- The grant will be applied to the cemetery workshop.
- SAPIC may, on its discretion, sponsor and partially finance the activity and may elect to contribute additional funds.
- Local groups will act as host (county agency, school, private individual, cemetery commission, township, etc.)
- Host will make all arrangements and be responsible for workshop, location, announcements, advertising, registration fees, and expenses.
- The instructor must be qualified to teach appropriate preservation methods. Any questions regarding an individual's expertise should be directed to the SAPIC officers.
- Upon completion of the workshop, the host will make a short report to SAPIC.

General Grants

The purpose of a general grant is to assist financially with the cost of repair to gravestones and related physical cemetery improvements such as brush removal, signs, chemicals, fencing, etc. The grant will be applied to a specific cemetery.

- A limited number of \$500 grants will be awarded. Priority will be given, but not limited to, individuals, groups, or organizations in the process of restoring neglected cemeteries in Iowa.

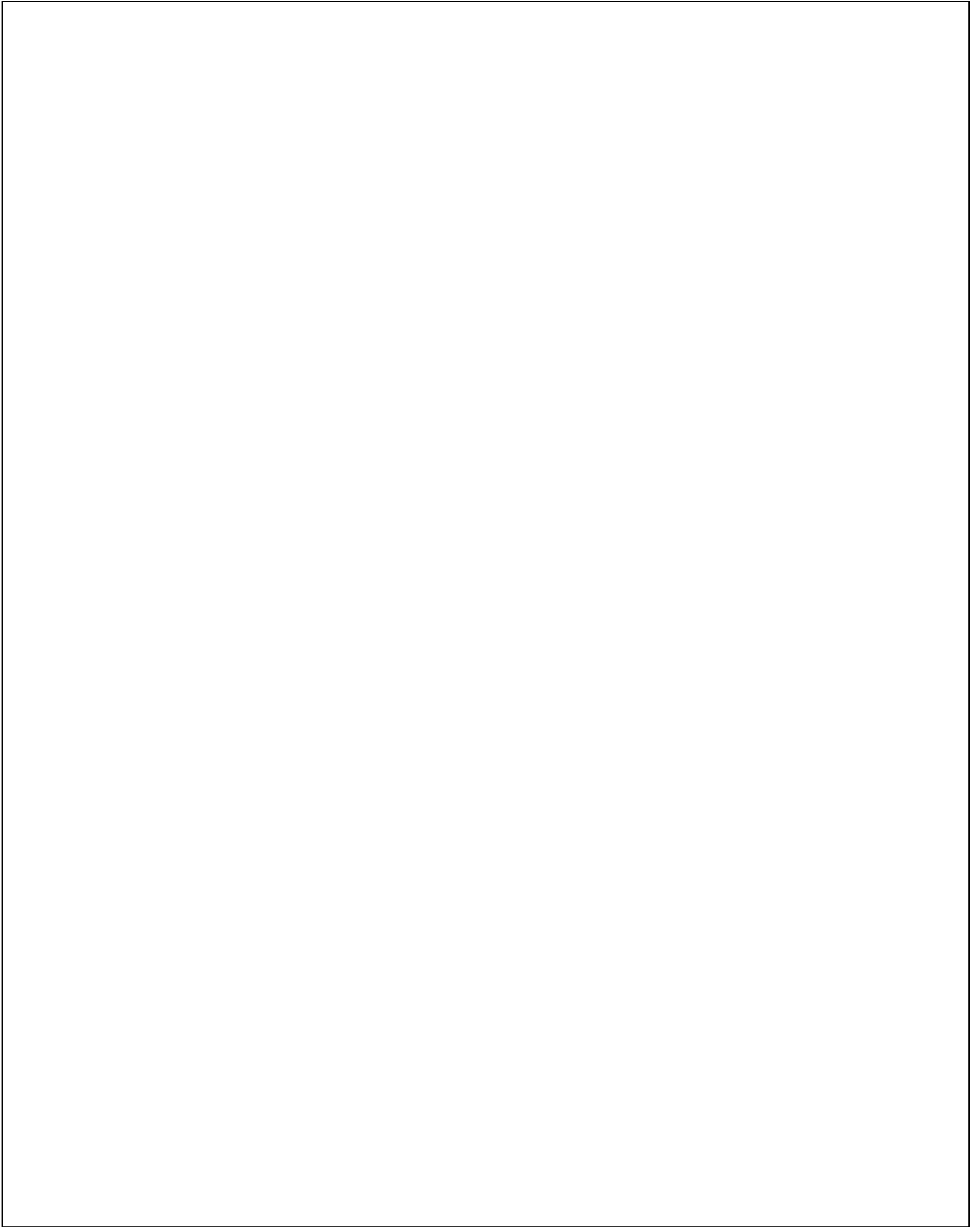
